### BUYER AGREES TO THE FOLLOWING CONDITIONS OF SALE:

Seller warrants the puppy to be in healthy and sound condition at the time of sale. Puppy will have received his/her first puppy vaccinations and will have been dewormed at least twice. Buyer has 48 hours to have the puppy examined by a licensed veterinarian for general health from the date of delivery/pickup \_\_\_\_\_ (excluding weekends and holidays). Failure to do so will result in any and all warranties being canceled. Seller accepts no liability for any communicable diseases after 48 hours from when the puppy leaves the possession of the Seller. If puppy does not pass the general health exam, Buyer agrees to notify breeder within the 48 hour window and provide a copy of the original signed licensed veterinary statement of health. Health guarantee does not cover any parasite, internal or external as this is a treatable condition.

No breeding guarantees are implied or expressed. There is no guarantee of mature size, show quality, ear set, bite or temperament. Seller will not refund money in any situation. Shipping is always the responsibility of the Buyer. All shipping costs related to any dog being purchased, as well as in relationship to any dog being replaced for any reason, are the responsibility of the Buyer. Seller shall not be responsible for death of said puppy/dog due to negligence or carelessness on any airline or other live animal carrier, their agents or employees, or the Buyer.

Seller cannot be responsible for Hypoglycemia (low blood sugar) or the effects of any stress related illness due to travel/rehoming. Buyer must make certain that their new puppy eats and gets plenty of rest. The seller will assume no responsibility if this puppy/ dog is given Ivermectin, Immodium or any of the Aussie-sensitive drug and suffers an adverse reaction. No other guarantees are given. I understand that the seller does not guarantee against Parvo or any kind of bacteria and/or viruses after 48 hours of leaving sellers property. I also understand that vaccination for these diseases does not guarantee that the animal will not contract a disease. Please be aware that places like Pet Smart and other pet friendly shopping stores can be a dangerous place for a puppy that hasn't completed his/her shots. Please be aware that the dog will also need boosters as recommended by buyers veterinarian. If the puppy has sustained health problems resulting from injury, or mistreatment or neglect, after leaving the seller, the seller will not assume responsibility for it and no refund/replacement will be forthcoming. There may be exception, to be determined by the seller. If abuse or neglect is found to be the case, seller may demand the puppy to be returned at the buyer's expense.

Buyer hereby releases breeder and agrees to hold harmless for any liability, injuries or damages to person or property caused by this puppy/dog. Buyer shall assume full responsibility for the health, temperament, and appearance of the puppy/dog upon leaving the premise of the Seller.

All parties mutually agree that all lawyer fees will be paid by the buyer. If seller stops breeding Australian Shepherds at any time, this contract is null and void. All puppies will carry our 4C name within the registered name of the puppy with ASDR. 4C Aussies reserves the right to first pick of every litter, the right to refuse the sale of any puppy, and/or cancel the transaction.

This contract is under the jurisdiction of the State of Nebraska. In the event of any dispute, the parties mutually agree that the dispute will be settled under the jurisdiction of Cedar County, Nebraska. Any and all attorney fees will be paid in full by the Buyer.
